NOTE: Juniors may enter only one age division and are not allowed to enter the adult draw except in the Open events. Juniors and adults may enter both singles and doubles and are limited to a total of two events in each

weekend, (*Total-four*). All players entered in the sanctioned events must present a current USTA card or purchase one at www.usta.com. In the adult sanctioned events, the NTRP rating classification guidelines will apply. Age eligibility for youth divisions is based on USTA rules and the age breaks are as follows:

12 & Under	Born 8-1-97 or after.
14 & Under	Born 8-1-95 or after.
16 & Under	Born 8-1-93 or after.
18 & Under	Born 8-1-91 or after.

The tournament director reserves the right to combine events.

ENTRY FEE: \$28 per person for first event, \$10 per person for each additional event if entered by May 31. \$5 late fee (*per entrant*) if received between June 1 and June 7. Entry fee includes athlete T-shirt, passes to SportFest and the Opening Ceremonies and a copy of the Nebraska Sports Council Yearbook. **If entering in both an individual and team or doubles event, both entries must occur in the same transaction to receive the multiple-event discount.**

NO UNIVERSAL TENNIS FORMS WILL BE ACCEPTED.

COMPETITION FORMAT: Matches are 2 of 3 sets with a 10-point match tiebreak in lieu of a third set. It is the referee's discretion to switch to alternate scoring from "regular" scoring in all matches. The change may be necessary to complete the tournament after inclement weather or other factors causing the tournament to fall behind its published schedule.

RULES: USTA rules will apply.
